

Stockholm, Sept. 30, O. S. On the 27th Instant the King and Queen of Sweden went from Stromholm to Kongfore, designing to proceed from thence to Grypholm, another Royal Seat in the Province of Sudermania, about 15 Leagues from hence: Their Majesties are expected to return hither the next Week. Letters from Gottenbourg have brought Advice of the Arrival there of Mr. Poyntz, the British Envoy to this Court, that he was preparing for his Journey hither, and might be expected here by the 7th of next Month. Letters from Carlscrona of the 21st Instant relate, that two Frigates which were fitted out there last Spring, had received Orders to go as Convoys to protect the Swedish Trade to and from Portugal against the Corsairs of Barbary. Colonel Freidenberg is arrived here from Cassel, and 'tis said is to take upon him a publick Character from the Landgrave his Swedish Majesty's Father.

Brussels, Oct. 21, N. S. Deputies from Flanders arrived here last Night, and are to have Audience of the Marquess de Prié, to declare to him the Content of that Province to the ordinary Subsidy for this Year, which is said to amount to the same Sum as that for last Year, viz. 1600000 Florins. The Marquess de Prié having signified to Count Bonneval an Order from the Emperour, that he should on Parole of Honour repair to the Castle of Spilberg in Moravia, that Count set out from Antwerp the 19th Instant. We hear he has taken his Way by Bolduc, and that Lieutenant Rivolotti, whom he had sent to Vienna, came back Time enough to accompany him.

Hague, Oct. 24, N. S. The States of the Province of Holland have passed a Resolution to compleat the Troops of their Contingent, upon the Foot of the State of War of the Year 1717; and continue their Deliberations on the Project for an Augmentation. This Day the Pensionary carried their said Resolution to the States General, with their pressing Instances to oblige the other Provinces to follow their Example. The Deputation resolved on to the Provinces of Friseland and Groeningen, composed of three Members of the States General, viz. M. Wassenar, Amerong, and Horn, and one of the Council of State, viz. M. Geldermalsen, will set out next Saturday. The Count de Bonneval is arrived here from Antwerp, and proposes to stay in this Country till he hears from Vienna, whither he has writ for an Explanation of the Emperour's Orders notified to him by the Marquess de Prié.
