NOTICE OF INTENTION TO APPLY TO STOP UP PART OF THE HIGHWAY AT A4 WELLINGTON STREET, SUBWAY NEAR WEXHAM ROAD, SLOUGH, BERKSHIRE

NOTICE is given that Slough Borough Council as Highway Authority for the highway known as A4 Wellington Street, Subway near Wexham Road, in the County of Berkshire intends to make an application to the Reading Magistrates Court sitting at Civic Centre, Castle St, Reading RG1 7TQ on 26 February at 2pm (virtual hearing), for an Order under section 116 of the Highways Act 1980 authorising the stopping of an area of the highway at A4 Wellington Street, Subway near Wexham Road as shown shaded blue on the attached plan ("Plan") on the ground that the highway is unnecessary.
