##### **THE ISLINGTON (FREE PARKING PLACES) (DISABLED PERSONS) (NO. 1) ORDER 2021**

##### **THE ISLINGTON (WAITING AND LOADING RESTRICTION) (AMENDMENT NO. 4) ORDER 2021**

1) NOTICE IS HEREBY GIVEN that the Council of the London Borough of Islington on 25th of February 2021 made the above mentioned Orders under Sections 6, 45, 46, 49 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 as amended, and of all other powers thereunto enabling.

2) The general effect of the Parking Places Order would be to in:

a) Chris Pullen Way, Clock View Crescent, Drovers Way, Jim Veal Drive, New Clock Tower Place and Shearling Way, introduce new residents permit parking places within the controlled parking zone IS-D operating from 9.30am to 4.30pm Mondays to Fridays;

b) The cost of a resident parking permit for a vehicle would be between £20 and £490.70, depending on emission levels for a 12 month period.

3) The general effect of the Disabled Persons Order would be to introduce disabled parking places in Jim Veal Drive, New Clock Tower Place and Shearling Way.

4) The general effect of the Waiting and Loading Order would be to introduce waiting restrictions operating at any time or from 9.30am to 4.30pm Mondays to Fridays in Chris Pullen Way, Clock View Crescent, Drovers Way, Jim Veal Drive New Clock Tower Place and Shearling Way at various locations at junctions and buildouts.

5) Make various amendments to the Traffic Orders, to bring them in line with the current on-street layout.

6) The Orders, which will come into force on 26th of February 2021, and other documents giving more detailed particulars of the Orders are available for inspection by the public. For reasons connected to the effects of coronavirus, the Council considers that it would not be reasonably practicable to make these documents available for inspection in person. 7) Any person who desires to question the validity of any of the Orders or of any provision contained therein on the grounds that it is not within the relevant powers of the Road Traffic Regulation Act 1984 or that any of the relevant requirements thereof or of any relevant regulations made there under has not been complied with in relation to the Orders may make application for the purpose to the High Court within six weeks from the date the Orders were made.
