N the 27th paft the Chevalier de Confans arrived here from Paris, being fent on the part of the Duke of Orleans to follicit their Catholick Majestice to be pleafed to confent to the Return of the Queen, King Lewis's Widow, to France, where it is refolved her Majefty shall live in some Royal Palace diftant from Parie, upon ber Dowry, as QueenDowager of Spains and 'tis not doubted those Catholick Majefties will grant their Confent. Letters from Malaga advise, that the Brandon a Spanish Man of War which failed with the Oneto from Cadiz, and was fappofed to be loft, had put into the Port of Malaga, but was in a very shattered Condition, being entirely unfit to proceed on her intended Voyage to the Weft-Indies to cruize against the Pyrates in those Parts. The fame Letters add, that there lately happened a great Storm upon that Coaft, that feveral Villages thereabouts had been overflowed by fudden Torrents, and a great many People drowned. Laft Night this Court received an Account from the Weft Indies, by the way of Cadiz, of Ad-miral Guevarra's having been caft away upon the Island of Santo Domingo, himfelf drowned, and only 80 Men faved of the Ship he was in : He failed from Cadiz the Beginning of laft Summer, with two Men of War of 30 Gune, laden with Quickfilver for Vera Cruz.

On the 22d of last Month Tarin, Dec. 13. the Princels de la Cifterna, first Lady of Honour to the Queco, received Orders to declare, that whereas heretofore no Ladies were admitted to Court but such as had been Maids of Honour to her Majesty or to Madame Royale, now upon the Princels of Piedmont's coming to Turin, her Majefty was pleafed to permit

all Ladies of Quality to appear at the Circles. and enjoy other Privileges as Ladies belonging to the Court. Upon this Notice, great Diligence was used by the Ladies to provide themselves with rich Cloathes against the Court's coming. On the 28th the Court came hither from the Venetia, on which Occasion the Cannon on the Ramparts of the Town and Citadel were thrice difchatged, the Garrifon was under Arms, and at Night the whole City illuminated. That Evening the Ladies attended at the Palace, and had the Honour for the first time of kifling the Princefs of Piedmont's Hand. The Paflages of Mount Cenis have been for obfructed with Snows for fome Days paft, that the Couriers could not perform their Journies without great Difficulty. The King and Princehunted the Stag on the 11th Joffant.

Berlin, Nov. 28.
