RIVER MEDWAY FLOOD RELIEF SCHEME (LEIGH FLOOD STORAGE AREA VARIATION)

WHEREAS the Environment Agency has submitted for confirmation to the Secretary of State for Environment, Food and Rural Affairs scheme amendments made by them under section 17(3)(c) to the River Medway (Flood Relief) Act 1976 ("the 1976 Act"), which would authorise them to vary the Scheme for the operation of the Leigh Flood Storage Area. The 1976 Act provided limited detail on the statutory process to be followed and therefore we are taking best practice under the Compulsory Purchase (Inquiries Procedure Rules) 2007, which have been suitably modified so as to be used for this inquiry.
