## City of Westminster

#### "GREEN SPINE" PROJECT - CHURCH STREET WARD

1. NOTICE IS HEREBY GIVEN that Westminster City Council on 5th July 2021 made the following Orders under sections 6, 45, 46, 49 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, as amended:

- The City of Westminster (Free Parking Places) (Disabled Permit Parking Places) (Amendment No. 71) Order 2021;
- The City of Westminster (Free Parking Places) (Disabled Persons) (Amendment No. 66) Order 2021;
- The City of Westminster (Motorcycle Parking Places) (Amendment No. 121) Order 2021;
- The City of Westminster (Parking Places) (B Zone) (Amendment No. 95) Order 2021;
- The City of Westminster (Prescribed Routes) (No. 6) Traffic Order 2021; and
- The City of Westminster (Waiting and Loading Restriction) (Amendment No. 443) Order 2021.

2. The general effect of the Orders will be, in connection with Phase 2 of the "Green Spine" project public realm improvements in the Church Street Ward, to:

(a) permanently close the following lengths of roads to vehicular traffic:

- Ashmill Street, between Salisbury Street and Ranston Street;
- Lisson Street, between Ashmill Street and Bell Street; and
- Salisbury Street, between Broadley Street and Ashmill Street;

(b) introduce one-way working in the following lengths of roads:

- Ashmill Street, eastbound between Ranston Street and Daventry Street;
- Corlett Street, south-eastbound for the whole length;
- Daventry Street, southbound between Ashmill Street and Bell Street;
- Penfold Place, south-westbound between Penfold Street and Corlett Street;
- Ranston Street, northbound for the whole length; and
- Salisbury Street, south-eastbound between Church Street and Broadley Street;

(c) reverse the existing one-way working in the following roads:

- Mulready Street, to operate south-westbound; and
- Whitehaven Street to operate north-eastbound; and

(d) make various amendments to parking provisions and waiting restrictions as set out in the Schedule to this Notice.

3. Please note that, following consideration of the responses to the public consultation, the City Council has agreed to permit contraflow cycling in Stalbridge Street and in the lengths of Ashmill Street, Corlett Street, Daventry Street, Penfold Place and Ranston Street described in paragraph 2(b) above.

4. The Orders for Phase 2, which will come into force on 8th July 2021, and other documents giving more detailed particulars of those Orders are available for inspection until 16th August 2021 at <http://westminstertransportationservices.co.uk/notices>. Please note that documents will not be available for inspection in person until further notice.

5. Any person desiring to question the validity of the Orders or of any provision contained therein on the grounds that it is not within the relevant powers of the Road Traffic Regulation Act 1984 or that any of the relevant requirements thereof or of any relevant regulations made thereunder have not been complied with in relation to the Orders may, within six weeks from the date on which the Orders were made, make application for the purpose to the High Court.
