1) NOTICE IS HEREBY GIVEN that the Council of the London Borough of Islington on 22nd of July 2021 made the above mentioned Orders under Sections 6, 45, 46, 49 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 as amended, and of all other powers thereunto enabling.

2) The general effect of the Orders would be to:

(a) introduce dedicated disabled bays in the following locations:

(i) outside No. 4-42 Catherall Road;

(ii) outside No. 25 Mayton Street;

(iii) outside No. 125 Newington Green Road;

(iv) outside No. 20 Thane Villas;

(v) in Dalmeny Avenue, outside 1 to 30 Kimble House;

(vi) in Piper Close, opposite Aldershaw; and

(vii) in St Thomas's Road, adjacent to No. 102 Gillespie Road; and

(b) make minor amendments to the existing parking places in those locations, in order to bring them in line with the new parking layout and better reflect the way existing restrictions have been implemented on street.
