SOUTH NORFOLK COUNCIL PLANNING (LISTED BUILDINGS AND CONSERVATION AREAS) ACT 1990, SECTION 69

BURSTON, FORNCETT, GISSING, THORPE ABBOTTS, WINFARTHING AND WRAMPLINGHAM CONSERVATION AREAS

NOTICE IS GIVEN under the provisions of Section 69 of the above Act that South Norfolk Council, after consulting with those affected, resolved on 26th July 2021 to amend the boundaries of Burstton, Forncett, Gissing, Thorpe Abbots, Winfarthing and Wrampingham Conservation Areas.

The principal effects of being included within a conservation area are as follows:

1. The Council is under a duty to prepare proposals to ensure the preservation or enhancement of the area.
2. Permission from the Council may be required for the demolition of buildings in the area.
3. Special publicity must be given to planning applications for development in the area.
4. In carrying out any functions under the Planning Acts (and in particular in determining applications for planning permission), the Council and the Secretary of State are required to take into account the desirability of preserving or enhancing the character or appearance of the area.
5. Six weeks' notice must be given to the Council before works are carried out to any tree in the area.

LANCASTER CITY COUNCIL TOWN AND COUNTRY PLANNING ACT 1990 TOWN AND COUNTRY PLANNING (CONTROL OF ADVERTISEMENTS) (ENGLAND) REGULATIONS 2007 DIRECTION UNDER REGULATION 7 TO CONTROL THE DISPLAY OF 'TO LET' BOARDS

Notice is hereby given that on 1 September 2021, Lancaster City Council ("the Council") will bring into force a Direction under Regulation 7 of the Town and Country Planning (Control of Advertisements) (England) Regulations 2007 ("the 2007 Regulations") to restrict the display of advertisements relating to the letting of residential premises, which are displayed on the land or premises to which they relate, within the wards of Bulk, Castle, John O'Gaunt, Marsh, Scotforth East and Scotforth West within the District of Lancaster.

The effect of a Direction under Regulation 7 of the 2007 Regulations is to take away the deemed consent granted by Regulation 6 of the 2007 Regulations for temporary advertisements described in Class 3A in Part 1 of Schedule 3 to the 2007 Regulations in so far as it relates to advertisements for the letting of residential premises. This would mean that no advertisement signs for the letting of residential properties could be displayed on the land or premises within the prescribed area without the Council's express consent.
