N the 26th past, the Obsequies of the late King Lewis were performed with great Pomp in the Royal Convent called the Incarnation; a very magnificent Mausoleum having been erected for that Purpose in the Middle of the Church. At this Ceremony affifted the principal Officers of his Majesty's Houshold, the Grandees, Nobility, and Councellours of the several Tribunals; and Father Navajas, a Trinirarian Fryar and a celebrated Orator here, preached the Funeral Sermon. On the 27th in the Morning a Chapter of the Knights of the Order of the a Chapter of the Knights of the Order of the Golden Flece was held in the Presence of his Catholick Majesty at the Buen Retiro, when the Marshal de Fesse was invested with the Collar of that Order, and took the Oaths according to the Statutes. The Queen and the Infantes assisted at the Ceremony, and afterwards all the Knights went into the King's Apartment, where the Queen presented to the Marshal the Radge the Queen presented to the Marshal the Badge of the Order richly set with Diamonds; and last Night when the Marshal took his Leave of the King, his Majesty made him a Present of a Sword having the Hilt set with D amonds. faid Marshal has fixed the 8th Instant for the Day of his Departure for Paris. On the 28th past died Don Joseph de Moscoso, Brother to the late Count de Altamira: His Widow is the Daughter and sole Heiress of the late Duke of Najera, by which Marriage he acquired the Titles of that noble Family, but has left no Issue. The Chevalier de Constans, who came hither some Months ago to settle the Treaty for the Queen Widow's Return to France, set out for Paris on the 2d In-Stant: At his Audience of Leave their Catholick Majesties presented him with a Diamond Ring. This Day their Catholick Majesties went to St. Ildefonso to take a View of some new Works and Gardens that have been made there; and will return hither on the 8th Instant. Dublin, March 3. Monday the 1st Instant being the Anniversary of the Birth-Day of Her Royal Highness the Princess of Wales, the same was observed here with great Solemnity. At Noon there was a numerous Appearance of the Nobility and other Persons of Distinction at the Castle to compliment the Lord Lieutenant upon this Occasion, and the great Guns at the Barracks fired several Rounds, and were answered by Vollies from the Regiments drawn out upon Oxmantown Green. At Night there were Bonsires and Illuminations; a Play was acted by his Excellency's Order for the Entertainment of the Ladies; and afterwards there was a Ball at the Castle.
