### THE ENVIRONMENT AGENCY DEPARTMENT FOR ENVIRONMENT, FOOD AND RURAL AFFAIRS LAND DRAINAGE ACT 1991 THE NORFOLK RIVERS INTERNAL DRAINAGE BOARD ORDER 2022

Notice is hereby given that the Secretary of State for Environment, Food and Rural Affairs in exercise of the powers conferred upon him by section 3(5) and (7) of the Land Drainage Act 1991, proposes to make an Order confirming a Scheme submitted by the Environment Agency under section 3(1) of the Act.

The scheme makes provision for:

- i) the reconstitution of the Norfolk Rivers Internal Drainage Board to reduce the number of elected members of the Board from 15 to 10
- ii) matters supplemental to or consequential on the reconstitution

#### LONDON BOROUGH OF EALING TOWN AND COUNTRY PLANNING ACT 1990

THE COUNCIL OF THE LONDON BOROUGH OF EALING hereby gives notice that they have made an Order "the London Borough of Ealing (Stopping Up of Highways) (No.2) Order 2022" under section 247 of the above Act to authorise the stopping up of the following lengths of highway which are shown hatched and coloured black on the stopping up order plan: -

Detail 1 the access area to Nos. 7 to 30 Buckingham Avenue:

(a) the west side, an irregular shaped area of highway extending northwards from the back of the footway of the main carriageway of Buckingham Avenue for an approximate distance of 18.1 metres with varying widths of between 1.6 metres and 8.4 metres;

(b) the east side

(i) an irregular semi-circular shaped area of highway extending northwards from the back of the footway of the main carriageway of Buckingham Avenue for an approximate distance of 4.1 metres with a varying width of between 2.1 metres and 8.9 metres;

(ii) an irregular shaped area of highway extending southwards from the northern extremity of this access area for an approximate distance of between 6.0 and 10.0 metres with a width of 5.8 metres at its northern extremity.

Detail 2 the access area to Nos. 31 to 54 Buckingham Avenue:
