GARWAY ROAD AND WESTBOURNE GROVE

1. NOTICE IS HEREBY GIVEN that Westminster City Council proposes to make the following Orders under sections 6, 45, 46, 49 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, as amended:

- The City of Westminster (Motorcycle Parking Places) (Amendment No. *) Order 202*;
- The City of Westminster (Parking Places) (B Zone) (Amendment No. *) Order 202*;
- The City of Westminster (Waiting and Loading Restriction) (Amendment No. *) Order 202*.

2. The general effect of the Orders would be, in connection with the installation of a "zebra" pedestrian crossing outside Nos. 62 to 72 Westbourne Grove, to:

- (a) introduce "at any time" loading restrictions at the junction of Garway Road and Westbourne Grove;
- (b) extend the double yellow line "at any time" waiting restrictions on the east side of Garway Road, at its junction with Westbourne Grove, southward by 6.6 metres;

(c) relocate the motorcycle parking place on the east side of Garway Road, adjacent to No. 73 Westbourne Grove, to the west side of the road, outside Nos. 17 to 23 (replacing a residents' parking place – see also paragraph 2(d) below); and

(d) relocate the residents' parking place outside Nos. 17 to 23 Garway Road to outside No. 18, replacing a length of single yellow line waiting restrictions.

3. Notice is also given, in accordance with the provisions of section 23 of the Road Traffic Regulation Act 1984, that the Council intends to introduce a "zebra" pedestrian crossing outside Nos. 62 to 72 Westbourne Grove which, together with its associated zig-zag markings, would extend 39 metres west of the western kerb-line of Garway Road.
