Madrid, May 7, N. S. On the 1st Instant being St. Philip's Day, the whole Court went out of Mourning; and there was a great Appearance of the Grandees, Nobility, and other Persons of Distinction, who kissed his Catholick Majesty's Hand upon this Occasion. His Catholick Majesty having directed his Ambassadors who accompany the Infanta to hasten her Journey out of France, it is reckoned she will be upon the Frontiers of Spain on the 10th Instant, whereupon Orders have been given to furnish the Palace at Guadalaxara, for which Place their Catholick Majesties design to set out from Aranjuez on the 20th Instant, in order to receive there the Infanta.
