Notice is hereby given that on 15 August 2022 the Council of the London Borough of Camden made the above orders under Sections 6, 45, 46, 49 and 124 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, as amended. The general nature and effect of the orders is to designate disabled parking places either in general or for specific individuals, together with associated changes to existing parking restrictions as set out below:

ALLCROFT ROAD: conversion of the northernmost 6.6 metre section of the residents' parking place opposite nos. 38 and 40 Allcroft Road to a dedicated disabled person's parking place.

CANFIELD GARDENS: conversion of a 6.6 metre section of the residents' parking place outside nos. 24 and 26 Canfield Gardens to a dedicated disabled person's parking place.

CANNON HILL: revocation of the dedicated disabled person's parking place outside nos. 48 to 57 Marlborough Mansions with the kerbside length being designated with a 24-hour prohibition on waiting. A 24-hour prohibition on waiting, including for the purposes of loading / unloading will also be designated between the two parking places outside the access road to the electricity sub-station adjacent to nos. 25 to 32 Marlborough Mansions.

LAXTON PLACE: designation of a dedicated disabled person's parking place outside no. 8 Laxton Place and designation of 24-hour waiting restrictions along the length of the east side of the road.

REGENT'S PARK ROAD: conversion of a 6.6 metre section of the shared-use residents' / paid-for parking place outside no. 182 Regent's Park Road to a dedicated disabled person's parking place. YORK WAY: revocation of the dedicated disabled person's parking place outside Saxon Court and the space to be merged with the adjacent disabled persons' parking place (Blue Badge bay).

Any person desiring to question the validity of the orders or of any provision contained therein on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1984 or that any of the relevant requirements thereof or of any relevant regulations made thereunder has not been complied with may, within 6 weeks of the date on which the orders were made, make application for the purpose to the High Court.

THE BARNET (CHARGED-FOR PARKING PLACES) (AMENDMENT NO.**) ORDER 20** THE BARNET (20MPH SPEED LIMIT) (NO. **) TRAFFIC ORDER 20**

NOTICE IS HEREBY GIVEN that the Council of the London Borough of Barnet propose to make the above-mentioned Orders under Sections 6, 45, 46, 49,51 to the Road Traffic Regulation Act 1984 and all other enabling powers.

Through engagement with local community members, Barnet Council understands that Finchley Central lacks an obvious civic 'centre' to support local civic life and the high street economy. In response, the Council has developed proposals for a new public space scheme, located around Tesco. The new space spans both sides of Ballards Lane, taking advantage of the wider pavements in this area and the adjacent side roads

Prior to this notice a formal public consultation was undertaken in Autumn 2021 by the Council on the proposed scheme, which was well received. - 1. As part of a scheme to create a new civic centre for Finchley Central, the general effect of the Orders, would be to:-
- (a) introduce a restricted zone into the section of Ballards Lane, between Nos. 12 to 56 Ballards Lane and its junction with Redbourne Avenue and Hervey Close.

The restricted zone would introduce parking controls operating 'at any time' to prohibit waiting and loading by vehicles other than in the designated loading bay and a taxi rank provided;

(b) introduce the following measures in Ballards Lane:-

- i. Introduce a loading only parking bay operating 'at any time' every day of the week with a maximum stay of 20 minutes opposite Nos.25 to 29 Ballards I ane N3.
- ii. Introduce a taxi rank for 3 vehicles operating 'at any time' on the southeast side of Ballards Lane outside Nos.48 to 50 Ballards Lane.
- iii. Remove lengths of no loading 'at any time' restrictions on the southeast side of Ballards Lane between Nos.12 to 18 Ballards Lane and on the northwest side of Ballards Lane between Nos.3 and 9 Ballards Lane.
- iv. Remove lengths of existing Paybyphone payment parking bays operating 8am to 6.30pm, Monday to Saturday (Maximum stay 1 hour 30 mins) on both side of Ballards Lane between Nos.32 to 56 Ballards Lane.
- v. Remove existing Bus Stop clearways outside Nos.26 to 32 Ballards and also outside Nos.19 to 27 Ballards Lane.
