vi. Remove lengths of existing No waiting 'at any time' restrictions on both side of Ballards Lane, between Nos. 12 to 56 Ballards Lane and also its junctions with Redbourne Avenue and Hervey Close.

vii. Remove a taxi rank for 2 vehicles on the north-east side of Ballards Lane, outside Tesco.

viii. Remove a disabled blue badge permit holders only parking bay outside The Joiners Public House on Ballards Lane.

2. In order to mitigate for the loss of short term parking facilities on Ballards Lane within the proposed restricted zone, the general effect of the orders would be to introduce lengths of Paybyphone payment parking bays operating 8am to 6.30pm, Monday to Saturday (Maximum stay 1 hour 30 mins) on Popes Drive N3 between Shakespeare Road and The Grove N3 and also outside No.4 Albert Place N3.
