(v) Shepperton Road, at a point 12.4 metres north-west of a point opposite the south-eastern wall of No. 2 Shepperton Road.

(b) prohibit the passage of all motor vehicles except 'CBE' permit holders, at the following locations

(i) Ecclesbourne Road, at a point 1.0 metres south-west of the northeastern wall of No. 1 Halliford Street;

(ii) Englefield Road, at a point 16.5 metres north-west of the north-western kerb-line of Crowland Terrace;

(iii) Halliford Street, at a point 4.3 metres south-east of the southeastern kerb-line of Ecclesbourne Road (measurement includes the kerb build-out):

(iv) Ockendon Road, between the common boundary of Nos. 5 and 7 Ockendon Road and a point 2.5 metres south-east of that common boundary.

(c) prohibit the passage of all motor vehicles except buses and 'CBE' permit holders, at the following locations:

 (i) Dove Road, at a point 6 metres south-east of the south-eastern kerb-line of Henshall Street (measured on the south-west side of Dove Road);

(ii) Downham Road, at a point 26.5 metres west of the western kerbline of Southgate Road (measured on the south side of Downham Road);

'CBE' permits allowing vehicles to pass the points listed in paragraphs (b) and (c) above will be available to disabled person's badge holders who are residents of premises listed in the Schedule to this Notice, by application to the Council.

(d) prohibit all vehicles, except pedal cycles and authorised vehicles ('CBE' permit holders):

(i) proceeding in Crowland Terrace, from turning left into Englefield Road:

(ii) proceeding a generally south-westward direction in Ecclesbourne Road, from turning left into Halliford Street;

(iii) proceeding in a generally north-eastward direction in Henshall Street, from turning right into Dove Road;

(iv) proceeding in a generally south-westward direction in Henshall Street, from turning left into Dove Road;

(e) prohibit all vehicles, except pedal cycles:

(i) proceeding in Ecclesbourne Road, from turning right into Elmore Street;

(ii) proceeding in Elmore Street, from turning left into Cleveland Road;
(iii) proceeding in a generally south-eastward direction in Halliford Street, from turning right into Ecclesbourne Road;

(f) introduce 'at any time' waiting restrictions in the following locations:(i) Cleveland Road, both sides, between a point 5 metres north of the northern kerb-line of Elmore Street and a point 15 metres north of that kerb-line;

(ii) Downham Road, north side, between a point 20 metres east of the south-eastern kerb-line of Cleveland Road and a point 31.5 metres east of that kerb-line;

(iii) Downham Road, south side, between a point 3.5 metres east of a point opposite the eastern wall of Nos. 1 to 12 Downham Court, Downham Road and a point 22 metres west of the north-western kerb-line of Southgate Road;

(iv) Ecclesbourne Road, both sides, outside No. 47 Ecclesbourne Road and at the side of No. 1 Halliford Street;

(v) Elmore Street, north-east side, outside Nos. 104 to 108;

(vi) Halliford Street, both sides, outside Nos. 1 and 2 and Nos. 60 and 61;

(vii) Ockendon Road, north-east side, between a point 2 metres northwest of the common boundary of Nos. 1 and 3 Ockendon Road and a point 7.9 metres south-east of that common boundary;

(viii) Ockendon Road south-west side, between a point 2.5 metres south-east of the common boundary of Nos. 2 and 4 Ockendon Road and a point 8.7 metres south-east of that common boundary;

(ix) Shepperton Road, north-east side, between a point 10 metres north-west of the north-western kerb-line of Rosemary Street and a point 5 metres north-west of that kerb-line;

(x) Shepperton Road, south-west side, between a point 10 metres north-west of the north-western kerb-line of Rosemary Street and a point 6.4 metres south-east of that kerb-line;

(g) amend parking places as follows:

(i) in Cleveland Road, shorten the CPZ 'T' permit holders parking places on the east and west sides, outside and opposite Nos. 67 and 69 Cleveland Road, each by 10 metres;

(ii) in Downham Road, remove the 5.5 metre-long shared-use (CPZ 'L' permit holders / 2-hours maximum stay pay and display) parking place on the south side outside Trafalgar Point, No. 137 Downham Road and remove the 11.5 metre-long shared-use (CPZ 'L' permit holders / 2-hours maximum stay pay and display) parking place on the north side, opposite the vehicle access leading to the rear of Downham Court;

(iii) in Ecclesbourne Road, (A) on the north-western side, outside No. 47 Ecclesbourne Road and at the side of No. 62 Halliford Street, shorten the shared use (CPZ 'T' permit holders / 2-hours maximum stay pay and display) parking place by 8 mtres; (B) on the south-eastern side, opposite No. 47 Ecclesbourne Road, shorten the existing CPZ 'T' resident permit holders parking place by 5.5 metres;

(iv) in Elmore Street, (A) relocate the disabled bay from outside No. 106 to outside No. 102; and (B) remove the 10.8 metre-long CPZ 'T' permit holders parking place on the north-east side outside No.108 Elmore Street;

(v) in Halliford Street, shorten the CPZ 'L' permit holders parking places on the north-east side and south-west sides, outside and opposite Nos. 60 and 61 Halliford Street, each by 8 metres;

(vi) in Ockendon Road, shorten the CPZ 'T' permit holders parking place on the north side outside No.1 Ockendon Road, by 9.8 metres and the CPZ 'T' permit holders parking place on the south side outside No. 2 Ockendon Road, by 6.2 metres;

(vii) in Shepperton Road, shorten the 2-hours maximum stay pay and display parking place on the south-west side outside No. 17 Shepperton Road by 16.4 metres and shorten the shared-use (CPZ 'L' permit holders / 2-hours maximum stay pay and display) parking place on the north-east side, approximately 5 metres north-west of Rosemary Street, by 5 metres;

(viii) reinstate parking places in Elmore Street, outside No. 110 to 116, and Halliford Street, outside and opposite No. 62, that were previously suspended as part of an experimental traffic scheme.

4. Any person who wishes to question the validity of the Orders, or of any provisions contained therein on the grounds that it or they are not within the relevant powers of the Road Traffic Regulation Act 1984 or that any requirement thereof or any relevant regulations made thereunder has not been complied with in relation to the Orders, may make application for the purpose to the High Court within six weeks from the date on which the Orders are made.
