## DEFRA

### THE ENVIRONMENTAL PROTECTION (PLASTIC PLATES ETC. AND POLYSTYRENE CONTAINERS ETC.) (ENGLAND) REGULATIONS 2023

Notice is hereby given that the Secretary of State intends to introduce legislation to restrict the supply of single-use plastic plates, bowls, and trays and ban the supply of single-use plastic balloon sticks and cutlery and single-use expanded or foamed extruded polystyrene food containers and cups.

These regulations will come into force on the twenty-fourth day after the day on which they are made. The Government's intention is to bring these regulations into force on 1 October 2023, subject to Parliamentary approval.
