Hambourg, September 11.

HE King of Denmark having a few Days ago come over into Holstein, stopped three Days at Gluckstadt, and having viewed the Regiments in Garrison there, set out Yesterday from thence, to go by Itzehoe to Rendesbourg, where some Troops are to pass in Review before him. From thence his Majesty will take his Way by Fredericksort, Eckelnforde, and Schleswig, to return to Denmark. The Senate of this City sent Deputies to wait on his Danish Majesty at Gluckstadt, but they were not admitted. Mr. Wych, his Britannick Majesty's Envoy Extraordinary, having had Audience there of the King of Denmark, is returned hither. M. Gabel, the Danish Admiral, came Yesterday to Altena, to view the new Fort which is building in the Neighbourhood of that Place; and then fet out to meet the King his Master at Rendesbourg.

Brussels, Sept. 19. On Sunday last the 16th Instant, the Marquess de Ross, the French Minister
residing here, gave a very splendid Entertainment
in the Palace of Egmont, on Occasion of the most
Christian King's Marriage. Count Daun, Governour General of the Austrian Netherlands, with
his Lady, and the chief of the Nobility of both
Sexes, were upon the Marquess's Invitation prefent at this Entertainment. The Prince and
Princess of Sultzbach, Proprietors of the Marquisate of Bergen op Zoom, having let to Farm the
Revenues of that Marquisate, are going to reside
in the Dutchy of Neubourg, on the Invitation of
the Elector Palatine. Prince Alexander de la
Tour-Taxis, and Count Daun our Governour's
Son, are returned from Fontainebleau, whither
they went to see the French King's Marriage celebrated. We have received Advice by an Express,
that the Archdutchess Elizabeth is arrived at

Prague on her Way hither from Vienna: And her Journey is so settled, that on the 3d of October she will pass by Maestricht, the 4th by Louvain, and arrive the 6th at the Seat of Ter-Vuren, where her Highness will stay till the Palace here is got ready, as also the Triumphal Arches which the Magistrates of this City have ordered to be erested against she makes her Entry; as was done for the Reception of the Archeduke Albert and his Consort Isabella, and of the Cardinal Infant, former Governours of these Provinces.

Hanover, Sept. 7, O. S. On the 2d Instant Colonel du Bourgay, Envoy Extraordinary from His Majesty to the Prussian Court, returned with his Lady to Berlin. The same Day his Majesty took the Diversion of Hunting, as he did also Yesterday, and was entertained at Dinner at the Country Seat of M. Dehne, chief Minister to the Duke of Wolfembuttle, who is come hither with a Commission from his Master to settle the Ceremonies, in order to his having an Interview with his Majesty, and other Affairs. Upon Advice of the Archdutchess's being set out from Vienna for the Austrian Netherlands, Prince William of Hesse-Cassel, Governour of Maestricht, set out from hence on the 5th for that Place, to receive her Highness there jointly with the Deputies of the States General. The Queen of Prussia designs to go from hence the Beginning of next Week, and the Court will go into Mourning immediately after her Departure for the Prince d'Aoste, Grandfon to the King of Sardinia.
