HOLOCAUST MEMORIAL BILL

NOTICE IS HEREBY GIVEN that the Secretary of State for Levelling Up, Housing and Communities has introduced in the present Session of Parliament a Bill under the above name or short title for purposes of which the following is a concise summary:-

1. The Bill provides for the Secretary of State to incur expenditure in relation to the construction, use, operation, maintenance or improvement of a memorial commemorating the victims of the Holocaust and a related centre for learning.
2. The Bill provides that section 8(1) and section 8(8) of the London County Council (Improvements) Act 1900, which require that Victoria Tower Gardens in the City of Westminster shall be maintained as a garden open to the public, do not prevent the construction, use, operation, maintenance or improvement of a memorial commemorating the victims of the Holocaust and a related centre for learning (as referred to in the paragraph above) being carried out at Victoria Tower Gardens.

The Bill has been introduced into the House of Commons as a public Bill. In the House of Commons, objection may be made to the Bill by depositing a Petition against it in the Private Bill Office during a period which begins the day after the Bill is read a second time in that House and lasts for 25 calendar days, unless that House orders otherwise. In the House of Lords, objection to the Bill may be made by depositing a Petition against it in the Office of the Clerk of the Parliaments; and the period during which petitions can be submitted begins the day after the Bill is read a first time and the petitioning period will last for a minimum period of 25 calendar days, the period to be decided by the Chairman of Committees.
