HARBOURS ACT 1964 (AS AMENDED) PROPOSED LYNMOUTH HARBOUR EMPOWERMENT ORDER NOTICE OF APPLICATION FOR A HARBOUR EMPOWERMENT ORDER

NOTICE IS HEREBY GIVEN that North Devon Council ("the applicant") has applied to the Marine Management Organisation ("MMO") for a Harbour Empowerment order under section 16 of the Harbours Act 1964

The proposed Harbour Empowerment order would modernise and consolidate the statutory harbour powers applying in relation to Lynmouth Harbour and formally appoint the applicant as statutory harbour authority for Lynmouth Harbour. The proposed Harbour Empowerment order provides for clarity on the limits of Lynmouth Harbour; the establishment of an advisory body or bodies consisting of harbour stakeholders with which the applicant is required to consult on material matters; modernised powers of management and control of Lynmouth Harbour to vest in the applicant including provisions relating to powers of general direction and special direction, the making of byelaws, navigational safety, conservation, dredging, moorings, bunkering, levying of charges and the use of harbour revenue; and powers to vest in the applicant which include the power to borrow, to establish a reserve fund, to develop or dispose of land, and to grant tenancies. To facilitate the above, article 58 of the proposed Harbour Empowerment order revokes the Acts and Orders set out in Schedule 2 to the proposed Harbour Empowerment order.

The proposed Harbour Empowerment order would not authorise the construction or alteration of a project or confer development consent. Accordingly, Council Directive 85/337/EEC on the assessment of the effects of certain public and private projects on the environment (as amended) which is codified by Council Directive 2011/92/EU (as amended by Directive 2014/52/EU) does not apply to the proposals and no environmental statement has been supplied.

A copy of the draft Harbour Empowerment Order and accompanying documents is deposited at the offices of the applicant at North Devon Council, Lynton House, Commercial Road, Barnstaple, EX31 1DG and at The Town Hall, Lee Road, Lynton Devon, EX35 6HT. These may be inspected at all reasonable hours until the expiry of the forty-two day period referred to below.

Any person desiring to make an objection or representation concerning the application should write to the Marine Licensing Team, Marine Management Organisation, Lancaster House, Hampshire Court, Newcastle Upon Tyne, NE4 7YH or email to harbourorders@marinemanagement.org.uk. An objection representation should:

i. be received before the expiry of a period of 42 days starting with the date at the foot of this notice;

ii. be made in writing quoting reference HRO/2022/00007;

iii. state the grounds of the objection or representation;

iv. indicate who is making the objection or representation; and

v. give an address to which correspondence relating to the objection or representation may be sent.

The MMO will pass to the applicant a copy of any objections and other representations received.

If an objection is duly made and not withdrawn then the MMO may cause an inquiry to be held. Any objections duly made and not withdrawn and any representations duly made will be considered before the MMO decides whether or not to make the order.

TOWN AND COUNTRY PLANNING ACT 1990 THE STOPPING UP OF HIGHWAYS (LOWER GWESTYDD LANE, **NEWTOWN, POWYS) ORDER 202-**

The Welsh Ministers propose to make an Order under section 247 of the Town and Country Planning Act 1990 ("the 1990 Act") to authorise the stopping up of the length of highway described in Schedule 1 to this Notice and to provide for the length of new highway described in Schedule 2 to this Notice as well as to improve the area of highway described in Schedule 3 to this Notice. The Welsh Ministers are satisfied that stopping up is necessary, and it will be authorised only in order to enable the development to be carried out in accordance with planning permission granted under Part 3 of the 1990 Act by the Powys County Council on 21 June 2022 with reference 21/1661/FUL described in Schedule 4 to this Notice.

The Stopping Up of Highways (Lower Gwestydd Lane, Newtown, Powys) Order 202- ("the Order"), if made, will cease to have effect if planning permission in respect of the development expires or is revoked.

Where objections cannot be resolved and the Order becomes subject to a Public Inquiry ("PI"), all correspondence is copied to the Inspector of the PI and is available in the PI library when it becomes publicly available.
