The DCO is for the proposed Lower Thames Crossing ("the Project"), which is a new road connecting Kent, Thurrock and Essex through a tunnel beneath the River Thames. The Project's main proposals

- Approximately 14.5 miles (23km) of new road, with a maximum speed limit of 70mph, connecting to the existing road network from the A2/M2 to the M25:
- Two new tunnels, one southbound and one northbound;
- Improvements to the M25, A2 and A13, where the Lower Thames Crossing connects to the road network:
- New structures and changes to existing ones (including bridges, buildings, tunnel entrances, viaducts, and utilities such as electricity pylons) along the length of the new road; and
- A free-flow charging system, where drivers do not need to stop but pay remotely, similar to that at the Dartford Crossing.

Summary of Proposed Provisions

Since the Application was accepted for examination, the Applicant has identified that "Additional Land" within the meaning of the Infrastructure Planning (Compulsory Acquisition) Regulations 2010 ("the 2010 Regulations") is required to accommodate certain changes to the Project.

As required by the 2010 Regulations, the Applicant has submitted the Proposed Provisions to the Examining Authority appointed on behalf of the Secretary of State to consider the Application and the Examining Authority has now made procedural decisions accepting these Proposed Provisions as part of the Application. Details of the Proposed Provisions are set out below.

Proposed Provision One

• An initial notification of a proposed change to the application was submitted to the Examining Authority on 16 March 2023 [Additional Submission AS-0831 which is also found at https:// infrastructure.planninginspectorate.gov.uk/wp-content/ipc/uploads/ projects/TR010032/

- The notification included details of three proposed changes, one of which required "Additional Land" (referred to as Change MRC03 in the notification of change dated 16 March 2023) within the meaning of the 2010 Regulations. That change is referred to as Proposed Provision One in this notice.

- The change involves the relocation of the temporary Linford bore pipeline (Work No. MUT6) 250m further west of the residents at East Tilbury. The realigned pipeline would remain within the existing Order Limits and the redesign has considered the working room needed for National Grid Electricity Transmission to construct, operate and maintain Work No. OH4 (the ZJ Route) in its proposed alignment. - Following the conclusion of the minor refinement consultation, the Applicant submitted a Change Application to the Planning Inspectorate on 2 August 2023, which included details of Proposed Provision One in the form of an extract of the Book of Reference, accompanied by a land plan identifying the additional land, a Statement of Reasons as to why the additional land is required and details of how the acquisition would be funded. Proposed Provision One was also accompanied by a revised draft DCO, a report setting out responses to the consultation and how these were considered and a number of additional documents set out in Table 6.2 of the Change Application. Proposed Provision Two
