### ROAD RESTRICTIONS

#### NATIONAL HIGHWAYS LIMITED ROAD TRAFFIC REGULATION ACT 1984-SECTIONS 14(1)(A), 15(2) AND PARAGRAPH 27(1) OF SCHEDULE 9 THE A38 TRUNK ROAD AND THE A5148 TRUNK ROAD (NEAR LICHFIELD, STAFFORDSHIRE) (TEMPORARY RESTRICTION AND PROHIBITION OF TRAFFIC) ORDER 2023

NOTICE IS HEREBY GIVEN that National Highways Limited (Company no.9346363) has revoked an existing Order and made a new Order on the A38 Trunk Road and the A5148 Trunk Road, near Lichfield, in the County of Staffordshire, to allow railway bridge construction works to be carried out in connection with HS2.

For the purposes of this notice –

“Streethay underbridge” means the underbridge of the link road leading from the southbound carriageway of the A38 to the A5127, at Streethay; and

“Hilliard's Cross overbridge” means the overbridge of the link road leading to and from Wood End Lane, to and from the southbound carriageway of the A38, at Hilliard's Cross.

The effect of the Order will be to, at different times: –

(1) impose a 30 miles per hour speed restriction on –

(a) the northbound carriageway of the A38 between points 300 metres south and 540 metres north of the centreline of Streethay underbridge; and

(b) the southbound carriageway of the A38 between points 540 metres north and 300 metres south of the centreline of Streethay underbridge;

(2) impose a 40 miles per hour speed restriction on –

(a) the northbound carriageway of the A38 from a point 2000 metres southwest of the centreline of Streethay underbridge, to a point 300 metres northeast of the centreline of Hilliard's Cross overbridge;

(b) the southbound carriageway of the A38 –

(i) from a point 500 metres northeast of the centreline of Hilliard's Cross overbridge, to its junction with the A5148 at Swinfen; and
