VERY Week now produces fresh Accounts of the Progress of the Turkish Armies in Perfia. The Pasha of Babylon or Bagdat has taken the City and Province of Lorestan, which yielded to him upon Terms, after having driven away their Governour called Ali Meidan, who refused to submit; and that Pasha is said to have since marched to Huveis towards Bassora, to subdue that Part of the Country. It is likewise given out that Abdullah Pasha, who commands another Army, has taken the City of Erdebit by Capitulation; and that Mustapha Pasha, Seraskier of a third Army, has made himself Master of several Places, between the Provinces of Schirvan and Ghilan.

Madrid, Now. 12, N. S. Their Catholick Majesties are still at the Escurial, where it is said they will remain till the End of this Month. This Day his Catholick Majesty made the Count de Altereza, an Arragonian Nobleman, a Grandee of Spain, in order to equal him with others of his Countrymen who followed the Emperour's Party in the late War, and obtained that Dignity from his Imperial Majesty. Paris, Nov. 28, N. S. The King leaves Fontainebleau this Morhing, and goes for three Days to Petit Bourg, a Seat belonging to the Duke d'Antin, in the Road to Versailles.
