STOPPING UP OF FOOTPATH AT/ADJACENT TO WILLOW WALK, THE GRANGE ESTATE, N2 8EL (STOPPING UP ORDER NO.3 2023) On 9th of January 2024 the London Borough of Barnet confirmed the above Order without modification.

The effect of the Order as confirmed is to stop up the southern public footpath north of Willow Walk from Point A being the back edge of footpath on Central Avenue to Point B being back edge of footpath on High Road/A1000 covering a length of around 77m and shown in bold black on the Order map.
