3. The general effect of the 'Parking Places' Order would be to designate a permit holders parking place in that length of Beresford Avenue, which lies on the south-east side, from 2.40 metres south-west of the common boundary of Nos. 98 and 102 Beresford Avenue south-westward for 20.60 metres.

4. The Council has also approved a proposal to install a speed table also referred to as a speed cushion under section 90 A-F of the Highways Act 1980 in Beresford Avenue generally outside Nos. 133 and 135. The speed table would be no higher than 75 millimetres at the highest point with 1:20 gradient ramps.

5. The general effect of the 'Waiting and Loading Restriction' Order would be further to amend the Brent (Waiting and Loading Restriction) Order 1979, so that: -

(a) waiting by vehicles (otherwise than for the purpose of delivering or collecting goods or loading or unloading a vehicle) would be prohibited between 8.30 a.m. and 6.30 p.m. on Monday to Friday in the lengths of streets specified in Schedule 2 to this Notice;

(b) waiting by vehicles for the purpose of delivering or collecting goods or loading or unloading a vehicle would be prohibited for a period of more than 40 minutes in the same place in the length of street specified in Schedule 2 to this Notice;

(c) the sale or offer for sale of goods from a vehicle would be prohibited (except on Sundays) in the lengths of streets specified in Schedule 2 to this Notice, unless there is in force a valid licence issued by the Brent Borough Council or the goods are immediately taken into or delivered at premises adjacent to the vehicle from which the sale is effected;

(d) the use of any vehicle or of any animal or the wearing of fancy dress or other costume, wholly or mainly for the purpose of advertising would be prohibited in the lengths of streets specified in Schedule 2 to this Notice;

(e) any existing prohibition on the waiting by vehicles, the sale or offer for sale of goods from a vehicle or the use of any vehicle or animal or the wearing of fancy dress or other costume wholly or mainly for the purpose of advertising in the lengths of streets specified Schedule 2 to this Notice would be revoked

(f) to make minor drafting amendments to the existing restrictions to conform with the current on-site layout.

6. The prohibitions referred to in sub-paragraphs 4(a) and (b) above would not apply in respect of anything done with the permission or at the direction of a police constable in uniform or in certain circumstances, e.g., the picking up or setting down of passengers; the carrying out of statutory powers or duties; the taking in of petrol, etc., from roadside petrol stations; to licensed street traders, etc. The usual exemption relating to vehicles displaying a disabled person's "Blue Badge" would apply.

7. Copies of the proposed Orders, of the relevant Orders of 1979 and 2019 (and of the Orders which have amended those Orders), of the Council's statement of reasons for proposing to make the Orders and of maps which indicate each length of road to which the Orders relate can be inspected during normal office hours on Mondays to Saturdays inclusive until the end of a period of 6 weeks from the date on which the Orders are made or the Council decides not to make the Orders at Brent Customer Services, Brent Civic Centre, Engineers Way, Wembley, Middlesex, HA9 0FJ.
