 NOTICE OF TEMPORARY TRAFFIC ORDER WITNEY/SOUTH LEIGH, VARIOUS ROADS - 7.5TONNE WEIGHT RESTRICTION**

Date of Order: 27/08/2024

Coming into force: 07/09/2024

This Order is being introduced because of construction of the 'A40 Shores Green Interchange Access to Witney' scheme.

A 7.5 tonne Goods Vehicle weight limit is requested by South Leigh Parish Council to deter heavy traffic from travelling through the village. The scheme is anticipated to be completed September 2026.

The effect of the Order is to prohibit goods vehicles in excess of 7.5tonnes from using South Leigh Road from the A40 with Chapel Road and Station Road into South Leigh village, and along Stanton Harcourt Road to the B4449, and the unnamed road from the A40 Barnard Gate to South Leigh. Appropriate traffic signs will be displayed to indicate when the measures are in force.

The County Council is satisfied that due to the nature of the works this Order will remain in force until the works are completed or the order is revoked, whichever is the sooner. (Ref: T14325/AC)
