IS Majesty came this Day to the House of Peers, and being in His Royal Robes seated on the Throne, with the usual Solemaity, Sir William Sanderson, Gentleman Usher of the Black Rod, was sent with a Mesage from His Majesty to the House of Commons, commanding their Attendance in the House of Peers; the Commons being come thither accordingly, His Majesty was pleased to give the

Royal Affent to

Orders are sent to M. Sommessdyk, who commands the Dutch Squadron in the Mediterranean, to remain there till December next.
