HE 2d Instant being the Birth-Day of the Instante Dom Carlos, was observed at Court with the usual Solemnity. The three Dutch Men of War that came in lately to careen, are making all possible Expedition to return to their Cruize at the Streights Mouth-Vice-Admiral Somelsdyck, with his Part of the Squadron, are to come here to clean as soon as they are relieved by these Ships. That Ship having passed the Streights Mouth, the Crew mutined and murdered William Mitchel the Master: They afterwards lest the Ship on the Coast of Portugal, and came on Shore at Lagos in Algarve, where they dispersed and sted different Ways to secure themselves. Two of them escaped from Villa Nova in Algarve before the Fact was known, but sour of the Crew were seized on the 3d of April last at St. Ubes, and are now in Prison there.
