Madrid, July 13, N. S.

**H**IS Catholick Majesty has ordered, that the Bull-Feast which was to have been performed on the 23d Instant shall be held a Day sooner; and his Journey to St. Ildefonso which was to have been on the 27th, is ordered for the 24th Instant. On the 10th Count Konigsbeck, the Emperour's Ambassadour, came from his Country-House, in order to stay here till the Court goes to St. Ildefonso, whither he is to follow, and to be lodged in the King's House at Balsayn a League from thence; on the 12th he had an Audience of their Catholick Majesties. Letters from Cadiz of the 9th Instant advise, that the Governour there having received a Letter from Court, acquainting him that some Seamen suspected of having the Plague were in the Lazareto of Leghorn, he had a Meeting with the Magistrates upon it, in which they resolved that all Ships coming in from the Mediterranean should be visited. Letters from Malaga of the 9th relate, that four Spanish Gallies arrived there from Cadiz on the 3d, and sailed the next Day for Cartagena, from whence they are to go to Barcelona, where they will joyn four other Gallies.

Madrid, July 22, N. S. The British Ambassadour Mr. Stanhope having received by a Messenger the King his Master's Orders upon what had passed on Occasion of the Duke of Ripperda's taking Refuge in his House, presented on the 13th Instant a Memorial to his Catholick Majesty by the Hands of the Marquess de la Paz: On the 14th his Excellency went to the Palace, and had a Conference with the said Marquess: On the 20th his Excellency had an Audience of the King and Queen, in which he complimented them on the Birth of the Infanta, and on the Queen's Recovery from her lying in; and was very graciously received by their Catholick Majesties. The Duke of Wharton has openly professed himself a Roman Catholick, by making his publick Abjuration of the Protestant Religion, and by going through all the other Ceremonies practised upon such Occasions.

Paris, July 31, N. S. Yesterday Morning all the Foreign Ministers were admitted to make

their Court to his most Christian Majesty in his Bed-Chamber: His Majesty appeared with so fresh and healthful a Countenance, that it was hardly visible he had been Sick.
