Stockholm, August 31.

O morrow being the Day for opening the appointed Diet, most of the Members of all the Orders, as well from Finland as the Provinces of this Kingdom are already come hither: But as not only all the Full Powers of the Proxies and Deputies must first be examined and read, the respective Speakers of each Order elected, and several other Matters regulated according to the new Ordinance for holding the Diet, it is reckoned these Formalities will employ the States sive or six Days before they can have their publick Audience of the King. The 25th Instant a small Russian Frigate arrived in this River, in sive Days from Petersbourg, having on board M. Platen Son in Law to Count Bassewitz and Marshal of the Duke of Holstein's Court, together with M. Gyllenbrook Cabinet Secretary and Gentleman of the Bedchamber to the said Duke. Last Week the Russian Envoy here desired that the King would be pleased to give Orders for permitting a Frigate, which he says will very soon bring hither an Ambassadour from the Czarina, to pass the Castles in the River and to come up to this Place; which it is said is granted, but it is not yet known with any Certainty who the Person is that comes on this Embassy.
