pole of your Government.

We are sensibly concern'd in common with your other Subjects, at the Prospect of any Event, that may be prejudicial to Trade and Commerce; upon which, the Strength and Safety of these Kingdoms, and particularly the flourishing Estate of these two great Cities, so manifestly depend. But that which most deeply affects us, and fills our Hearts with a just Indignation and Resentment, is the Engagement that has been entered into to set a Popish Pretender on your Throne. A Delign, which could be form'd and projected by none, but those who will not see and confider, to what Degree the Mildness and Justice of your Government, your constant and tender Care of the Welfare of your People, your steady Regard to the Constitution in Church and State, and your unshaken Resolution in maintaining the Protestant Cause, have established your Throne, and endeared you to your People.
