This Day their Majesties came from Hampton-Court to Hyde Park, where the four Troops of Horse-Guards, viz. the first com-manded by the Right Honourable Henry Lord Herbert, the second by the Right Ho-nourable Algernon Earl of Hertford, the third by the Right Honourable George Earl of Cholmondeley, and the fourth by the Right Honourable Richard Lord Viscount Shannon; as also the two Troops of Horse Grenadier Guards, viz. the first commanded by the Honourable John Fane, Esq; and the second by the Honourable Henry Berkeley, Esq; passed in Review before His Majesty, and made a very fine Appearance: After which, their Majesties returned to Hampton-Court.
