Y Letters from Commodore St. Lo, dated from on Board His Majesty's Ship the Lyon at Port Royal in Jamaica, July 24, 1728, we have an Account, That Captain Gray came in there the Day before with His Majefty's Ships the Lark, Lenox, Nottingham, Dragon, Tyger, Portland, and Diamond, from before Cartagena, having on
the roth of that Month, at Nine in the
Morning, received by the Conde de Avene, Commander of a Spanish Man of
War called the St. Lorenzo, Duplicates of his
Grace, the Duke of Newcastle's Letters Grace the Duke of Newcastle's Letters, fignifying His Majesty's Pleasure for the Execution of the Preliminary Articles, as likewise several Packets containing the like Orders from the King of Spain for the Commandant of the Galleons, the Governour of Cartagena, and the other Viceroys and Governours of the Spanish Colonies in A-merica; upon which Captain Gray had fent an Officer ashore at Cartagena with the Packet for the Governour of that Place, as likewise that which was directed to the Commandant of the Galleons, and acquainted them that he had received the King his Master's Orders to withdraw from that Coast, and that he should forthwith proceed to Jamaica, offering to convey any Packets they might have Occasion to send Home. When the Officer he fent athore carried them the News of the Peace, the whole Town

was filled with Joy, and Chearfulness appeared in the Face of every Person. That on the 3d of the said Month His Majesty's Ship the Solebay arrived at Jamaica with His Majesty's Orders above mentioned to the Admiral or Commander in Chief of His Majesty's Squadron, and Duplicates of those of the King of Spain to his Officers, which Ship Commodore St. Lo sent away on the 6th to Vera Cruz with the Packet directed to the Viceroy of Mexico, and the Greyhound to Portobelo with that directed to the Viceroy of Peru and the President of Panama; and that he was in Hopes he should dispatch all the Ships that were ordered Home in about three Weeks, except the Lyon and Nottingham, which having suffered at Sea, would take up some Time to be resitted.
