**O**N Saturday last one of His Majesty's Yachts arrived in the Maese, to carry over to England the Countess Dowager of Portland. Her Ladyship has been indisposed, but on being let Blood Yesterday she is better, and intends to go with her Daughters on board the said Yacht Tomorrow. Next Thursday the Prince of Nassau-Frise is expected here from Utrecht, he is to stay here some Weeks, as it is said, on Account of a Law-Suit depending before the Court of Justice of Holland, relating to some Estate of his Ancestors. Yesterday the Court of Justice of Holland examined the two Persons last committed to Prison for betraying their Trust in the Secretary of State's Office of this Republick. The States of Holland are like to continue their Session till the End of next Week, not having yet received the Consent of their Towns upon certain Domestick Affairs proposed to them. The Commissioners of the several Admiralties are come hither, to concert the fitting out of Men of War for the Service of the current Year.

*Paris, Feb. 16, N. S.* The President de Mesnard died the 10th Instant in a very advanced Age. The Prince de Tingri, Uncle to the Duke of Luxemburg, succeeds the Duke de Sully in his Government of Manté, and as the King's Lieutenant in the Mantoise. On the 10th M. Chauvelin, Son to the Intendant of Amiens, was married to Mademoiselle Ourfin. The Duke de Rochefaucault is shortly to be received in the Parliament as Duke and Peer. M. Poncarre, Son to the first President of the Parliament of Rouen, is to marry Mademoiselle de Cany, to whom the Marquis her Father gives in Part of her Fortune the Charge of President a Mortier, which he inherited of the late M. de Quevilly. The King has given to the

Abbot d'Avigeant, the Abbey of Chatellieres in the Diocese of Poitiers, worth 22000 Livres per Annum, but a Pension of 6000 is reserved to the Abbot's Uncle the Bishop of Montauban, who has resigned his Bishoprick in Favour of M. de Vallerac Agent of the Clergy. On the 10th Instant the Duke de Sully's Body was carried to Sully; his Heart is deposited in the Convent of the Nuns of St. Mary at St. Denis. The Abbot Ernos died lately as he was saying Mass in the Chapel of the Schools of St. Sulpice. M. de la Nauze of Agen; and the Abbot Paris of Seissel in Bugey, are chosen to fill up two Vacancies in the Royal Academy of Inscriptions. The Prince de Dombes and the Count d'Eu; Sons to the Duke du Main, having followed a Huntsman too closely near a Mill in the Neighbourhood of Chelles, they all three fell into the Water; the two Princes were with great Difficulty drawn out of the Water by the Assistance of the Miller. The Count d'Eu soon came to himself, but his Brother did not shew any Signs of Life; till his Mouth was forced open by the Miller's Knife, which by the Haste and Violence he used cut the Jaws and broke a Tooth. The Abbess de Chelles sent her Coach to carry them to Sceaux, the Duke du Main's House.
