A great Number of People of Diffinction waited upon his Highnefs with their Coaches out of the Town. Count Dehn arrived on Sunday Night from Wolfembuttel, and this Day is gone to Helvoetfluys to imbark To-morrow for England in the Packet-Boat. The Dutchels of Richmond fet out on the 13th Inftant for Paris ; but is to meet the Duke her Husband at Bruffels.
