**T**HE States of Holland and Westfriesland are still assembled. Yesterday arrived a Courier from their High Mightinesses Plenipotentiaries at the Court of France. The Lord Cowper is arrived here from England, to see these Provinces, and then will proceed on his Travels. On the 10th Instant two Dutch Men of War the Curacao and the Termeer, and four Frigates sailed from the Texel to cruize.
