N Sunday last the 24th Instant, at Six in the Evening, His Majesty arrived at Clausthall, and was received in the following Manner. All the Miners of that Town having rendez-vous'd in several Places appointed for them, about Four in the Afternoon, the chief Officers drew up those under their Command, about Eleven Hundred in Number, the rest being obliged to continue their Work in the Mines; and other Officers did the same with their Workmen employed about the Oar, to the Number of about 800; together with 150 Carters and Colliers. They were all posted in two Lines from the Entrance into the Town, on both Sides of the Street through which the king was to pass, as far as the Mint, where his Majesty chose to lodge, his own House not being entirely finished. Part of the Miners had their working Tools in their Hands, and the others had their Lamps lighted, their Officer than the Miners had the Miners had their Lamps lighted, the Miners had been the more than the miners had the miners had the more than the miners had the mine ficers standing before them with the Mine-Colours, and the Singers and Musicians, who saluted the King with their Musick. The Carters and Colliers with their white Frocks and Whips, were placed in the Market overagainst the King's House. One Company of Foot of Brigadier Wurm's Regiment stood in Parade over-against the Mint; and at His Majesty's approaching the Town the Bells were rung. The King's Ministers, with several other Gentlemen, as well as the Head-Officers of the Mines, stood before the Door of the House where His Majesty alighted. The King, after having changed his Cloaths, went on Foot to His House, where His Majesty, on a Balcony, in Company with a great many Gentlemen and Ladies, saw, marching by in Form, all the above-mentioned Miners and Workmen, their Musick playing before them, followed by the Carters and Colliers. This March being over, the Miners Boys made their Appearance, and His Majesty was pleased to throw Money amongst them. Then the Officers of the Mines were presented to His ther of the Chamber by Sig. de Santa Maria. Majesty; who afterwards went to Supper; On the 29th past the King arrived at Verduring which the Miners entertained His sailles, and returned Yesterday to Rambou-

ter two Hours Stay, came up by another Mine; there being a Communication under Ground between the two: His Majesty was attended on this Occasion by several Persons of his Retinue, M. De la Foret, M. Lannai, the Hon. Mr. Townshend, General Diemar, and others. After Dinner His Majesty saw the Manner of beating cleaning and melting the Oar, and observed the several Progresses of the Metal from the Mine to the Mint, where fome Crown-Pieces were coined in His Majesty's Presence. The 26th, 500 Miners from the Town of Andreasberg came to Clausthall, and desired Leave to pass before His Majesty, with their Colours and Musick; to which His Majesty graciously condescended. Yesterday in the Evening His Majesty came hither from Clausthall. This Morning at Nine a-Clock His Majesty went from hence to take the Diversion of Hunting a League beyond Hertzberg, and returned at Six in the Evening. To Morrow at Eight in the Morning, His Majesty sets out from hence for Munden.
