*Whitehall, September 6.*

**O**N Tuesday Night last Mr. Randall one of His Majesty's Messengers arrived from Hanover, with Orders from the King for His Majesty's Yachts to be got ready and sail under a proper Convoy to Holland, and wait His Majesty's Arrival there, in order to bring His Majesty over to England; which Orders were immediately signified by his Grace the Duke of Newcastle to the Lords Commissioners of the Admiralty. Yesterday Advice came from Hanover, that His Majesty intended to set out from thence on Monday next; upon which the Yachts were ordered to sail forthwith, as they did accordingly this Morning, to joyn their Convoy, and proceed to Holland under the Command of the Rt. Hon. the Lord Viscount Torrington.

*Kensington, September 9.*

Mr. Wiggs one of His Majesty's Messengers arrived this Morning from Hanover, with Letters dated last Friday the 5th Instant, which bring an Account, that His Majesty intended to set out from thence on Sunday Evening, and to be this Night at Helvoetsluys, in order to embark for England. This Messenger in his Passage, about half Seas over, saw Yesterday about Two in the Afternoon Eight Sail of Ships at a Distance, making for Holland; which the Captain of the Packet-Boat judged to be the Yachts and Convoy sent to attend His Majesty; and that though they had then a contrary Wind, yet it not blowing fresh, they might get to Helvoetsluys that Night or early this Morning.
