The Appearance was at both Times very numerous, and extremely splendid. On this Occasion the Guns in the Park and at the Tower were fired, and in the Evening there were Bonfires, Illumina-tions, and other publick Demonstration of Joy throughout London and Westminster.

hall, where a magnificent Entertainment was provided, at which were present the Great Officers of State, divers of the Nobility, Lords of His Majesty's most Honourable Privy Council, the Judges, and other Per-sons of Quality and Distinction.
