THE Marquês de Rouvroy, Lieutenant-General of the Marine, and Commander of the Order of St. Louis, died suddenly the 13th Instant in the Garden of the Tuilleries. The Marquês de Mouchy succeeds M. de Blouin in the Government of the Castle of Versailles, which during his Minority will be exercised by his Father the Duke de Noailles. M. Meliand having desired to lay down the Intendance of Lisle, is succeeded by M. Ory, Intendant of Perpignan.
