**T**HE Earl Waldegrave, his Britannick Majesty's Minister Plenipotentiary at this Court, is preparing to set out for England in a few Days on his private Affairs. The Imperial Ministers have held several Conferences within these three or four Days at Luxembourg and at this Place. Count Mercy, Prince Alexander of Wirtemberg, General Philippi Paderborn, and several others, propose setting out for Italy by the Middle of this Month, but the compleat List is not yet published.

Hambourg, June 9, N. S. Brigadier General Dubourgay, who has resided for several Years in the Quality of his Britannick Majesty's Envoy Extraordinary at the Court of Prussia, is arrived here with his Family, on his Return for England.

Yesterday Morning the King and Queen, with His Royal Highness the Prince of Wales, His Royal Highness the Duke, and their Royal Highnesses the Princesses, came from Richmond to Hyde Park, where His Majesty's Foot-Guards, viz. The First Regiment, commanded by the Right Honourable Sir Charles Wills Lieutenant-General of His Majesty's Forces; the Second Regiment, called the Coldstream Regiment, commanded by the Right Honourable Richard Earl of Scarborough; and the Third Regiment commanded by the Right Honourable John Earl of Dunmore, passed in Review before His Majesty, and made a very fine Appearance. After which their Majesties and their Royal Highnesses returned to Richmond.
