Dresden, July 18, N. S.

Count Lagnasco his Minister Plenipotentiary to the Court of Vienna, he set out the 15th Instant in the Morning for that Court; and Count Walstein, the Emperour's Minister here, having received Orders to return to Vienna, took his Leave of the King of Poland on the 14th, and went away the 16th in the Morning. The King of Poland sends away his great Baggage and Equipage for Warsaw the 26th Instant, and proposes setting out himself about the Middle of next Month. The 1200 Men of the Saxon Troops which he is permitted, by the Pasta Conventa, to have in Poland, are upon their March thither. We hear that a sew Days ago the King of Prussia passed throw Leipsick, and went to a House of Count Seckendorf in that Neighbourhood, where he staid a Day and a Night, and afterwards continued his Journey to Anspach, the said Count attending him. Count Truchses the Prussian Minister, has received his Letter of Revocation, but does not intend to deliver it till just before his Polish Majesty's Departure for Poland.

Hague, Fuly 25, N.S. The States of the Province of Holland adjourned their Assembly on Saturday last to the 9th of next Month. They put an End to the Assair of the new Tax on Houses, which is to be settled by eight Commissioners elected out of the several Towns, and one out of the College of the Nobles. Major General Sutton, his Britanick Majesty's Envoy Extraordinary to the

Court of Cassel, arrived here Yesterday, and set out this Morning for Amsterdam, thence to proceed on his Journey.

Hon, the Lords of the Treasury having appointed Money for paying of Half Pay to Sea Officers from the 1st of January 1729, to the 30th of June last, according to his late Majesty's Establishment on that Behalf: These are to give Notice, that the said Payment will beg'n to be made at the Treasurer of the Navy's Office in Broad-street, at Nine of the Clock in the Morning of the following Days, viz. On Monday the 10th of August next for the Captains, Tuesday the 11th for the Lieutenants, and on Thursday the 13th for Masters and Surgeons; That all Persons concerned may then and there attend to receive what may become payable to them, and not only bring with them the Assidavits required, touching their not having enjoyed the Benefit of any publick Employment, either at Sea or on Shore, during the Time they are to be paid the said Half Pay, but also produce Certificates that they have subscribed the Test, and taken the Oaths required by the Ast of Parliament to his present Majesty; and in take any of the said Officers shall not be able to attend themselves to receive their Money, but employ Attorneys for that Purpose, that the said Attorneys may produce the like Certificates and Assidavits from the Persons they are employed by.
