T is said the Grand Vizier has sent a very able Person along with the Persian Ambassadours to Schack Thamas, to endea-vour to prevent a War, and to perswade him to confirm the Treaty which was made with those Ambassadours here; and that the Vizier has likewife given Orders to the Balha of Babylon to do all that lies in his Power to terminate these Differences between the Porte and the Perfians in an amicable Manner. The Vizier will not begin his March from Scutari to Aleppo till the Beginning of September next; before that Time he expects an An-swer from Persia, and will regulate himself according to the Advices he shall receive 'Tis reckoned to be a March from thence. of 56 Days from Scutari to Aleppo, so that he cannot be at Aleppo before the Beginning of November at soonest. In case of a War, he will winter at Aleppo, and march with his Army to the Frontiers of Peria early in the Spring. It is likewife said, that if there is a War, the Grand Signior will go with his Army as far as Cognia, which is about half Way to Aleppo, and flay there during the Winter, and in the Spring proceed to the Frontiers, as there shall be Occasion for his Presence, with the Army. He will keep about 20000 Men with himself, and send the rest with the Vizier.

Hague, Oct. 3, N. S. Admiral Perez having received new Credentials from the prefent King of Morocco, and delivered them to the States, is now acknowledged here as Mi-

nister of that King. M. March, the new Prussian Minister, has taken Possession of the late King William's House called the Old Court, in which M. Meinertshagen dwelt for some Time. General Hompesch set out from hence some Days ago for Boisleduc, of which he is Governour. The States of the Province of Holland separated on Saturday last. During their Session a new Project was last. The Directors of the East-India Company, pursuant to the Liberty given them by the States, have dismissed the Crews of their two Ships taken and released by the Algerines from their Service. The Lord Baltimore and his Lady arrived here two Days ago, and defign to go to see Amsterdam and Utrecht.
