Every Morning, be-fore the Meeting of the Diet, we are told there is great Probability the Day will pro-duce a Marshal, from the vast Pains the Pri-mate, the Bishop of Cracow, and the Prin-de the Prin-d ces Wiefnowiesky give themfelves, to quiet and difpole the Minds of the Deputies for that Purpole; but fince it is in the Power of any one Member to ftop their proceeding to any one Member to ftop their proceeding to an Election, it is very much questioned whether they will ever come to that Point, as Matters now fland; if they do, there are at prefent but two Candidates, M. Scipion, and M. Maffalski Staroft of Grodno, M. Potocky the Primate's Nephew having de-fifted. M. Marcinkiewich, who has much infuited on the Diploma of Courland (which is in the Hands of Count Maurice of Saxony) being delivered up, before they proceed to the Election of a Marshal, is gone away, and left a Protestation, that he will not return unless he be fatisfied in that Point.
