HEREAS Henry Earl of Deloraine was duly elected and re-turned to be one of the Sixteen Peers of Scotland, to fit in the House of Peers of this present Parliament of Great Britain, and is fince deceased; In order to the electing another Peer of Scotland to fit in his Room, we do, by the Advice of our Privy Councel, iffue forth this our Royal Proclamation, strictly charging and commanding all the Peers of Scotland to assemble and meet at Holyrood-House in Edinburgh, on Friday the Nineteenth Day of February next ensuing, between the Hours of Twelve and Two in the Afternoon, to nominate and choose another Peer of Scotland in the Room of the faid Henry Earl of Deloraine deceased, by open Election and Plurality of Voices of the Peers that shall be then present, and of the Proxies of such as shall be absent, such Proxies being Peers, and producing a Mandate in Writing duly figned before Witnesses, and both the Constituent and Proxy being qualified according to Law. And we strictly charge and command, that this our Royal Proclamation be duly published at the Market-Cross at Edinburgh, and in all the County-Towns of Scotland, Twenty five Days at least before the Time hereby appointed for the Meeting of the said Peers to proceed to such Election.
