**L**AST Monday Morning the Empe-  
rour held a Council of State, and  
in the Afternoon gave several Au-  
diences. The same Day the Arch-  
dutchefs Mary Magdalen went to the Royal  
Monastery, to celebrate the Anniverfary of  
the Death of the Archdutchefs Eliza-  
beth, Queen of France, Confort of King  
Charles the Ninth, Daughter of the Empe-  
rour Maximilian, and Sifter of the Empe-  
rours Rodolph the Twelfth, and Mathias  
the First, Foundrefs of this Convent. Her  
Serene Highnefs dined there, and in the Eve-  
ning returned to Court. Tuesday in the Mor-  
ning the Emperour held another Council of  
State, and in the Afternoon their Imperial  
and Catholick Majefties, accompanied by the  
whole Court, were at the Opera. The  
Command of four vacant Regiments has been  
difpofed of by his Imperial Majefty in the fol-  
lowing Manner, Brown's Regiment of Foot  
to the Baron de Neulan, who was Colonel  
Commandant thereof; Lucinni's Foot to the  
Baron de Wachtendonk, Colonel Comman-  
dant of the Regiment of Guido Stahrenberg;  
Ottocare Stahrenberg's Regiment to the  
Count de Wallis, Colonel Commandant of  
the Regiment of the Count de Wallis, Ge-  
neral of the Artillery; and the Prince of  
Sultzbach's Regiment of Cuiraffiers, to the  
Serjeant General Count Kokorzova. The  
Duke de Liria, lately Ambaffadour from the  
King of Spain to the Emprefs of Ruffia, is  
arrived here.
