HIS Court has lately received an Express from Constantinople, by which they are informed that the Troubles in that Country are not yet appeafed, though the Grand Signior has put to death above 16000 Rebels fince he ascended the Ottoman Throne. This Court, as well as that of Constantinople, has received Advice from Persia, that the Turks had beat the Persians in a Skirmish near Erivan, and had cut off the Head of a Persian Officer of Distinction whom they had taken Prisoner in the Action. The Turks beheaded him as a Reprisal, because the Persians had done the same to a Turkish Officer whom they took when they were near Tauris. Notwithstanding the unsettled Situation of the Assairs of Turkey, this Court is resolved to send a Person of Note to compliment the Grand Signior on his Accession to the Throne; for which End Prince Cherbatoff, who was in Spain, is going very foon as Envoy Extraordinary to Lieutenant General Hen-Constantinople. ning, who has been many Years in Siberia to take Care of the Mines of that Province, is made a Knight of St. Alexander, and is foon to return in the same Employment to that distant Country. M. Lukin, who was a Major of the Preobrazensky Regiment of Guards, is made a Brigadier and Commandant of Riga; and Major Gallenishoff Kootusoff, of the same Regiment, is also made a Brigadier and Commandant of Narva. The 16th Instant the Czarina went and incamped near a Place called Carachova, about seven Miles

from hence, where she staid under her Tents, though we have had very rainy and cold Weather, and returned to Town the 19th in perfect Health.

Hague, Aug. 3, N. S. The States have ordered M. de Ginkel at Berlin, to complain

in very pressing Terms to the King of Pruffia, of new Violences used towards two of their Subjects, who going through the Country of Cleves, were arrested and forced to enlift themselves into his Prussian Majesty's Service; and a Resolution of their High Mightinesses on this Proceeding was likewise delivered Yesterday to M. Masch, the Prussian Minister. The States of Holland have ordered a Collection to be made through this Province on the roth of September next for the poor Vaudois, who have been obliged to leave their Country upon Account of Religion. The Prince of Naffau Orange is expected here this Evening from Dieren, and 'tis faid will refide here till the End of this Month. Our Ambassadour at Constantinople having sent hither one of his Interpreters with a Letter from the new Sultan, notifying to the States his Accession to the Throne; that Interpreter will set out next Monday on his Return by the Way of Vienna, having received his Dispatches and their High Mightinesses Anfwer to the Grand Signior's Letter.
