Petersbourg, Jan. 22, O. S.

THE 16th Instant in the Morning her Czarish Majesty made her publick Entry into this City. As soon as she was come to the Palace, all Persons of Distinction went to congratulate her upon her safe Arrival, as did also the Foreign Ministers. The 19th Instant being the Day of her Majesty's Accession to the Throne, there were great Rejoycings at Court; and the next Day General Count Munich, Governour of this Place, was declared President of the College of War, and it is thought he will soon be made Felt-Marshal.

This Evening Mr. Hammond arrived here from his Excellency the Earl of Chesterfield, His Majesty's Ambassadour Extraordinary and Plenipotentiary to the States General, with the Act of Concurrence of their High Mightinesses to the Treaty concluded the 16th of March last past, N. S. between His Majesty and the Emperour at Vienna, the said Act having been signed the 20th Instant, N. S. at the Hague, by the Ministers of His Majesty, the Emperour, and the States General.
