HE Consent of the States of Groningen to the Act of Concurrence of the States General to the Treaty of Vienna, concluded the 16th of March 1731, N. S. arrived here this Morning, and their Deputies are authorized to ratify the same. The States of Holland are assembled chiefly for the Disposal of the Civil and Military Employments vacant in their De-partment. The Regiment of Horse of the late General Cralingen, has been given to Brigadier de Boncourt.
