*Berlin, April 8, N. S.*

**C**OUNT Aspremont de Linden having executed his Commission at Potzdam, set out from thence on Sunday last for Nawen, the Prince Royal's Quarters, being charged with Compliments and Letters to his Royal Highness from their Imperial Majesties. That Gentleman goes from thence to the Court of Wolfenbuttel.

*Hague, April 11, N. S.* The States ratified Yesterday their Act of Concurrence to the Treaty of Vienna, and this Morning Count Zinzendorff, Ambassador Extraordinary and Plenipotentiary from the Emperour of Germany, and M. Dayrolle, his Britannick Majesty's Resident, exchanged the Ratifications of their respective Masters with those of their High Mightinesses. George Woodward, Esq; His Britannick Majesty's Envoy Extraordinary to the King of Poland, arrived here the 9th Instant, and proceeded this Morning in his Journey to Dresden.

*St. James's, April 5.*

This Day Prince Cantemir, Resident from the Czarina, had his first private Audience of his Majesty, to deliver his credential Letter, to which he was introduc'd by the Right Honourable the Lord Harrington one of his Majesty's Principal Secretaries of State, and conducted by Sir Clement Cottrell, Kt. Master of the Ceremonies.

He had afterwards a private Audience of the Queen in her Majesty's Apartment, to

which he was introduced by the Right Honourable the Earl of Grantham her Majesty's Lord Chamberlain, and conducted by the Master of the Ceremonies.

*St. James's, April 7.* This Day Prince Cantemir, Resident from the Czarina, had his first private Audience of his Royal Highness the Prince of Wales, to which he was introduced by Sir Clement Cottrell, Kt. Master of the Ceremonies.

And afterwards he was introduced to a private Audience of his Royal Highness the Duke, by the Master of the Ceremonies.
