**B**Y Letters from Corfica we have an Account, that the Prince of Wirtemberg came the 29th past, with the Troops under his Command, to Bastia, and brought with him, the chief Rebels of the Corsicans, who were put into the Fortrefs there; and that on the 4th Instant 30 Transport Vessels, under Convoy of a Genoese Galley, sailed from Bastia with 3000 German Soldiers on board for Genoa.

*Hague, June 24, N. S.* The States of Holland have under Consideration Means for raising a Sum of 350000 Guilders, which it is computed will defray the Charge of repairing the Timber-Work of the Diques of North Holland. Eight Ships from the East Indies are arrived in the Ports of this Country, and two more are expected.

Yesterday being the Day of His Majesty's happy Accession to the Throne, the Great Guns were fired at the Barracks, and answered by Volleys from the Regiments on Duty which were drawn out on Oxmantown-Green. And this Day at Noon their Excellencies the Lords Justices met at the Castle, and received the Compliments of the Nobility and other Persons of Distinction; after which their Excellencies, attended with the Guard of Battle-Axes and one of the Squadrons upon Duty, made a Tour round St. Stephen's Green; And the Night concluded with Bonfires, Illuminations, and all other Demonstrations of Joy.
